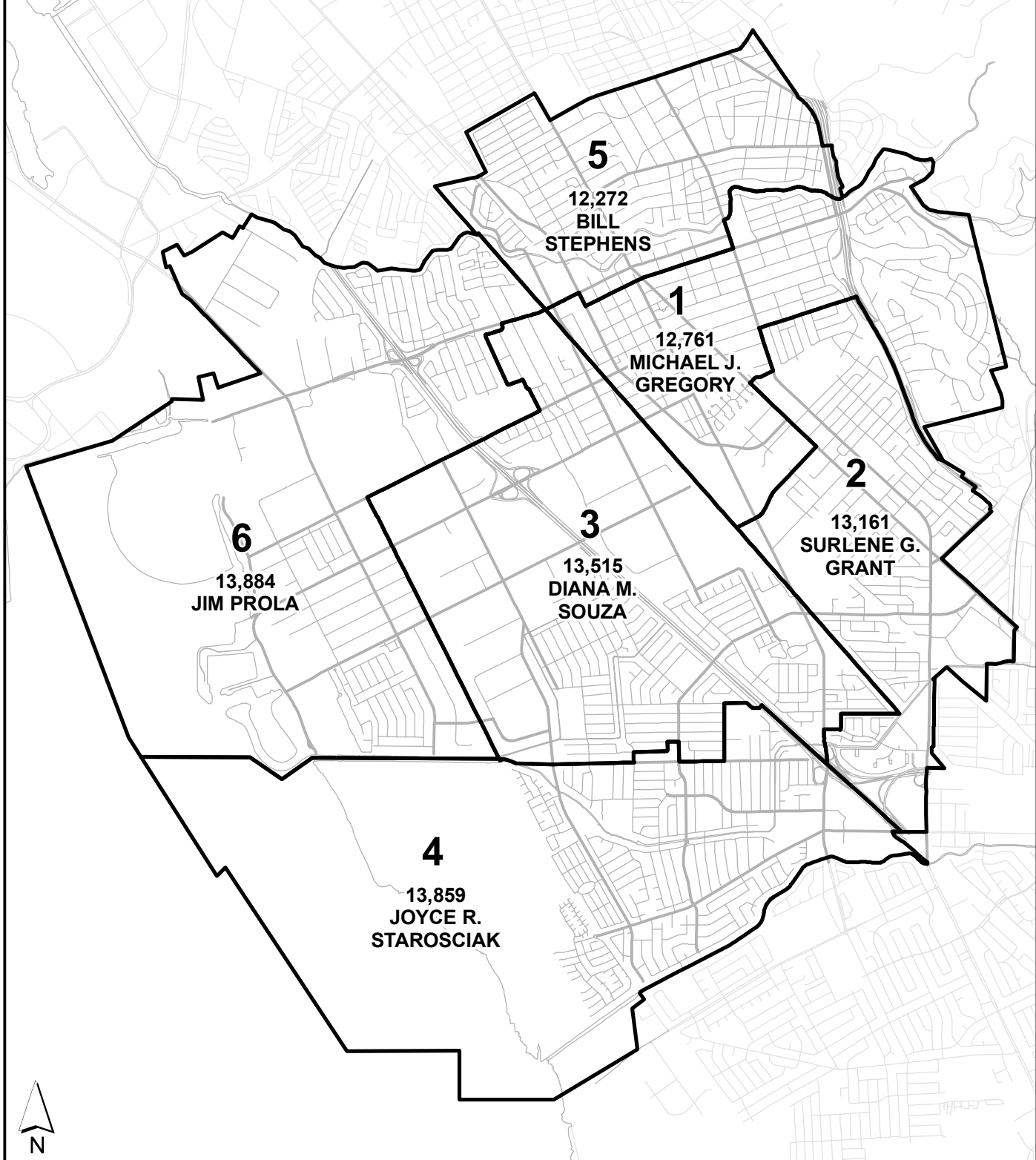
5. ADJOURN
