SUMMARY AND RECOMMENDATIONS

State law requires the posting of a Local Appointments List, to inform the public of the upcoming vacancies on the City's boards and commissions during the next calendar year. Staff recommends that the City Council review and approve by motion the posting of the 2013 Local Appointments List.

BACKGROUND

California Government Code Section 54970 et seq., known as the Maddy Act, is intended to raise the awareness of members of the community about volunteer opportunities on local boards, commissions, and committees. The Act requires the City Council, by December 31 of each year, to prepare and post a list of "...all regular and ongoing boards, commissions, and committees which are appointed by the legislative body of the local agency...with the name of the incumbent appointee, the date of appointment, the date the term expires, and the necessary qualifications for the position."

Analysis

The City has nine (9) regular boards and commissions whose members serve at the pleasure of the City Council. The terms of most board and commission members terminate upon the expiration of the regular term of the Mayor or the Councilmember representing the Councilmember district from which the member was appointed.

The 2013 Local Appointments List includes the following upcoming vacancies:

- Members representing Districts 2, 4, and 6, with terms expiring on December 31, 2012
- One member of the Rent Review Board, with term that expired on June 30, 2011
- Two members of the Rent Review Board, with terms expiring on June 30, 2013
- All members of the Youth Advisory Commission, with terms expiring on August 31,

No member of any board or commission shall be a member of any other board or commission or hold any paid office or employment in the City Government (San Leandro Municipal Code §1-3-125).
