SUMMARY AND RECOMMENDATIONS

The subject project will install a drainage system in a portion of Stenzel Park. Staff recommends the City Council award the contract to the lowest responsible bidder, Fanfa Inc., in the amount of \$123,000.00 for the subject project.

BACKGROUND

On March 2, 2009, the City received notice from the East Bay Regional Parks District (EBRPD) of its eligibility for \$3,740,998 in Measure WW Park Bond funds. The funds are for the development of neighborhood, community and regional parks and recreation lands and facilities. After completing a community process, the City developed a ranked list of City park improvement projects for the City Council to consider funding with these funds. In the 2010-2011 fiscal year budget, nine projects, including the Stenzel Park Drainage Project, were approved as part of the Capital Improvement Program.

City Staff noted that rainwater ponded at the northwest portion of the ball field at Stenzel Park. This is an ongoing issue that recurs each winter, affecting the usability of the field and creating maintenance problems.

This project will remove sections of turf and the upper layer of soil in the ponding area. An underground drainage system will be installed to increase the field's tolerance for water. The surface will be repaired with new top soil and sod.

<u>Analysis</u>

The bids were opened on June 27, 2013. Six (6) bids were received ranging from \$123,000.00 to \$201,589.00. Fanfa Inc. was determined by staff to be the apparent lowest

responsible bidder. The engineer's estimate for the work was \$119,410.25. Staff verified that the contractor has a valid license with the Contractors State License Board.

Previous Actions

- On February 17, 2009, by Resolution No. 2009-023, the City Council approved a resolution authorizing the application for local grant funds from EBRPD under Measure WW, the Park Bond Extension
- On June 3, 2013, by Resolution No. 2013-075, the City Council approved a resolution approving Plans and Specifications and Calling for Bids

Applicable General Plan Policies

This project is consistent with General Plan Goal No. 21 - Rehabilitation of existing parks.

Environmental Review

The project was determined Categorically Exempt under the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3). A notice to this effect was filed with the County on March 26, 2010.

Fiscal Impacts

The estimated total cost of the Stenzel Park Drainage project is \$178,930.00. The design phase cost was \$23,110.00, and the construction phase is estimated at \$155,820.00.

Budget Authority

The improvements will be funded using Measure WW bond funding in existing account 150-62-114, approved as part of the 2010-2011 CIP Budget.

WHEREAS, the City of San Leandro did, on June 27, 2013, publicly open, examine and declare all sealed proposals or bids for doing the work described in Resolution No. 2013-075 of the City Council of said City adopted on June 3, 2013, which resolution is hereby expressly referred to for a description of said work and for all particulars relative to the proceedings under said resolution; and

WHEREAS, said proposals were submitted to the Engineering and Transportation Director who has found that the proposal hereinafter mentioned is the lowest responsive bid for doing said work.

NOW, THEREFORE, the City Council of the City of San Leandro does RESOLVE as follows:

That said City Council hereby rejects all of said proposals or bids except that herein mentioned; hereby waives any irregularities in the proposal or bid of the lowest responsible bidder; and hereby awards the contract for doing said work to the lowest responsible bidder therefore, to wit Fanfa, Inc., at the prices named in its bid on file in the Office of the City Clerk.

BE IT FURTHER RESOLVED:

That if the above named contractor is unable to execute the contract, then the City Manager is authorized to award this contract to the next lowest responsible bidder, execute all documents to effect the award, and take all actions necessary to recover any bid security from the low bidder necessary to make the City whole in its acceptance of the lowest bid.
