Pedestrian/Bicycle Project Funding to Install Pedestrian Improvements

RECOMMENDATIONS

Staff recommends that the City Council adopt a resolution authorizing the City Manager or his designee to submit a request to the MTC for the allocation of Fiscal Year 2014-15 TDA Article 3 Pedestrian/Bicycle project funding to install pedestrian improvements.

BACKGROUND

In the nine-county Bay Area region, the MTC makes TDA funds available for pedestrian/bicycle purposes. The funds are from the Local Transportation Fund, which is from the State Legislature initiating a one-quarter percent sales tax in Alameda County in 1972. Each year, the MTC allocates TDA Article 3 funds to eligible claimants after review of applications from counties and congestion management agencies. Alameda County is responsible for submitting an annual program of projects that are initiated by each local agency in the county. The TDA grant funds are distributed by population.

Analysis

Annually, the City applies for TDA grant funds from the MTC for pedestrian improvements throughout the City. The City is entitled to \$41,898 for this next fiscal year (FY 2014-15). Additionally, the City will request an advance of \$30,000 from the FY 2015-16 allocation for a total allocation of \$71,898. The City is able to request an early allocation because some Alameda County jurisdictions are not using their allocations this year.

The TDA funds will be used to install the following: handicap ramps, sidewalk, sidewalk bulb-outs, pedestrian safety signage, accessible pedestrian traffic signals, and lighted

crosswalks at various locations citywide. The work is typically completed as part of the City's Annual Sidewalk Repair project and the end result is a more accessible City.

Previous Actions

- The City Council annually authorizes staff to apply for these funds
- On April 15, 2013, by Resolution No. 2013-048, the City Council authorized the filing of a claim with the MTC for allocation of TDA Article 3 funds for FY 2013-14

Applicable General Plan Policies

This project is consistent with the Bicycle and Pedestrian Goal (14) of the General Plan and Action 14.07-B: Pedestrian and Bicycle Crossing Improvements.

Board/Commission Review and Actions

On November 13, 2013, the Bicycle and Pedestrian Advisory Committee reviewed and approved the proposed project for the use of TDA funds as required by the MTC.

Environmental Review

This action will not have a significant impact on the environment, and thus is not subject to CEQA review.

Fiscal Impacts

\$71,898 is the amount the City is allocated in FY 2014-15, and there is no required match. Grant funds will need to be appropriated and will be reimbursed once all of the spending is complete (within a three year period).

Budget Authority

\$71,898 is the amount the City is allocated in FY 2014-15. The request for the appropriation of funds will be updated with the new amount in the CIP Budget for FY 2014-15.

TITLE: RESOLUTION Authorizing Submission of a Request to the Metropolitan

Transportation Commission (MTC) for the Allocation of Fiscal Year 2014-15 Transportation Development Act (TDA) Article 3 Pedestrian/Bicycle Project Funding to Install Pedestrian Improvements (provides for the submission of an application to the MTC for TDA Article 3 funds in the amount of \$71,898 for

pedestrian/bicycle projects)

WHEREAS, Article 3 of the Transportation Development Act (TDA), Public Utilities Code (PUC) Section 99200 et seq., authorizes the submission of claims to a regional transportation planning agency for the funding of projects exclusively for the benefit and/or use of pedestrians and bicyclists; and

WHEREAS, the Metropolitan Transportation Commission (MTC), as the regional transportation planning agency for the San Francisco Bay region, has adopted MTC Resolution No. 4108, entitled "Transportation Development Act, Article 3, Pedestrian and Bicycle Projects," which delineates procedures and criteria for submission of requests for the allocation of "TDA Article 3" funding; and

WHEREAS, MTC Resolution No. 4108 requires that requests for the allocation of TDA Article 3 funding be submitted as part of a single, countywide coordinated claim from each county in the San Francisco Bay region; and

WHEREAS, the City of San Leandro desires to submit a request to MTC for the allocation of TDA Article 3 funds to support the projects described in Attachment B to this resolution, which are for the exclusive benefit and/or use of pedestrians and/or bicyclists

WHEREAS, the City Council is familiar with the contents thereof; and

WHEREAS, the City Manager recommends approval of said submission.

NOW, THEREFORE, the City Council of the City of San Leandro does RESOLVE as

follows:

- 1. That the City of San Leandro declares it is eligible to request an allocation of TDA Article 3 funds pursuant to Section 99234 of the Public Utilities Code; and
- 2. That there is no pending or threatened litigation that might adversely affect the project or projects described in Attachment B to this resolution, or that might impair the ability of the City of San Leandro to carry out the project; and
- 3. That the project has been reviewed by the Bicycle and Pedestrian Advisory Committee of the City of San Leandro; and
- 4. That the City of San Leandro attests to the accuracy of and approves the statements in Attachment A to this resolution; and
- 5. That a certified copy of this resolution and its attachments, and any accompanying supporting materials shall be forwarded to the congestion management agency, countywide transportation planning agency, or county association of governments, as the case may be, of Alameda County for submission to MTC as part of the countywide coordinated TDA Article 3 claim.
