## 11. REPORT ON CLOSED SESSION ACTIONS TAKEN

City Attorney Pio Roda reported on the following actions:

Pursuant to Government Code section 54957.1(a)(3)(b), in the matter of Sipple v. City of Alameda et seq., the City Council voted to settle the case in the amount of \$134,649.76 related to miscollection by New Cingular Wireless of Internet usage taxes. The amount will be remitted back to AT&T for them to attempt to refund to AT&T customers within the City of miscollected Internet user taxes, which were collected through the telephone user tax.

In the matter of Heron Bay Homeowners Association v. City of San Leandro; Halus Power Systems; Louis A. Rigaud; real parties in interest, the City settled on the attorney's fees for \$13,500.

In the matter of Steven J. Ilmburger, Lonnie Ilmburger and Lonnie Ilmburger as guardian ad litem for Sydney R. Ilmburger v. City of San Leandro, the City agreed to

settle as follows: Steven and Lonnie Ilmburger will be paid \$235,000; and Laura Stangey, guardian ad litem for Sydney Ilmburger, a minor, will be paid \$15,000; for a total of \$250,000, related to their claims of inverse condemnation, nuisance, dangerous condition to public property, and negligence, related to a sewer backup.
