SUMMARY AND RECOMMENDATIONS

This action will confirm the City's commitment to completing the project under the grant terms, approve a project status report, and request construction funds from the granting agency.

Staff recommends approval of a resolution confirming compliance with grant terms, certifying a project report, and requesting allocation of construction funds.

BACKGROUND

This project will improve safety for pedestrians along West Juana Avenue, a street that connects BART to Downtown San Leandro, and security for bicycles at the San Leandro BART station. This project is listed as a high priority in the San Leandro Bicycle and Pedestrian Master Plan and is consistent with the City's Transit Oriented Development Strategy.

This project will improve the pedestrian environment on West Juana Avenue between San Leandro Boulevard and Hays Street by installing high visibility decorative crosswalks and sidewalk bulb outs at all crossings and by adding pedestrian level lighting. This project will also improve bicycle facilities at the San Leandro BART station by installing new electronic bike lockers.

The City will contract for construction of the majority of this project via a competitive bid; improvements adjacent to the Marea Alta project (between San Leandro Boulevard and Carpentier Street), which is currently in construction, will be built by the developer. The electronic bicycle lockers will be supplied and installed by BART's vendor under a contract with the City. Contracts above \$50,000 will be brought to the City Council for approval.

The City has already approved using RM 2 grant funds for the design of this project; additional action is required to approve use of the \$360,000 in remaining RM 2 funds for construction.

Analysis

The RM 2 grant terms are reasonable and the City can comply with them without hardship. The project report is true and accurate, and design of the improvements is complete. Staff is ready to bid, award, and construct the project. Allocation of construction funds from this grant will allow this project to proceed.

Current Agency Policies

Council Goal F: Maintain and enhance San Leandro's infrastructure

Previous Actions

- On September 14, 2014 by Resolution No. 2014-100, the City Council authorized the City Manager's Execution of a Grant Funding Agreement for Transportation Fund for Clean Air (TFCA) funding and the City's commitment to install bicycle lockers at the San Leandro BART station.
- On October 7, 2013 by Resolution No. 2013-131, the City Council made a commitment to the grant terms, approved a project status report, and requested RM 2 grant funds for the design phase of this project
- On June 17, 2013 by Resolution No. 2013-087, the City Council authorized the City Manager's Execution of a Grant Funding Agreement for Measure B Funding, Committing the City to Spend the Necessary Matching Funds and Providing City Assurance to Complete the West Juana Pedestrian Improvements Project

Applicable General Plan Policies

- 18.02 Identify Capital Improvements and other measures which improve the safety of bicyclists, pedestrians, and motor vehicles on San Leandro streets.
- 18.05 Pursue grants for the improvement of pedestrian, bicycle, and motor vehicle safety.
- 19.01 Promote the design of streets and buildings that make San Leandro's streets more attractive and inviting for pedestrians, bicyclists, and public transit users.

Environmental Review

This project is categorically exempt from CEQA per section 15301: minor alteration to existing facilities. A notice of exemption was filed with the Alameda County Recorder on August 27, 2014.

Summary of Public Outreach Efforts

A gas station at the NW corner of West Juana Avenue and Hays Street may be impacted by construction activity. Staff has discussed the project with the station owner and he is supportive.

A bus stop will be relocated adjacent to the property at the SW corner of West Juana Avenue and Clarke Street. Staff has discussed the project with the property owner and she is supportive.

Fiscal Impacts

The estimated project cost is \$866,000 including design, construction, and inspection.

TITLE: RESOLUTION Declaring Project Compliance as the Regional Measure 2 (RM

2) Implementing Agency for the Downtown San Leandro BART Pedestrian

and Bicycle Access Project

WHEREAS, SB 916 (Chapter 715, Statutes 2004), commonly referred to as Regional Measure 2, identified projects eligible to receive funding under the Regional Traffic Relief Plan; and

WHEREAS, the Metropolitan Transportation Commission (MTC) is responsible for funding projects eligible for Regional Measure 2 funds, pursuant to Streets and Highways Code Section 30914(c) and (d); and

WHEREAS, MTC established a process whereby eligible transportation project sponsors may submit allocation requests for Regional Measure 2 funding; and

WHEREAS, allocations to MTC must be submitted consistent with procedures and conditions as outlined in Regional Measure 2 Policy and Procedures; and

WHEREAS, City of San Leandro is an eligible sponsor of transportation project(s) in Regional Measure 2, Regional Traffic Relief Plan funds; and

WHEREAS, the Downtown San Leandro BART Pedestrian and Bicycle Access Project is eligible for consideration in the Regional Traffic Relief Plan of Regional Measure 2, as identified in California Streets and Highways Code Section 30914(c) or (d); and

WHEREAS, the Regional Measure 2 allocation request, attached hereto in the Initial Project Report and incorporated herein as though set forth at length, lists the project, purpose, schedule, budget, expenditure and cash flow plan for which City of San Leandro is requesting that MTC allocate Regional Measure 2 funds.

NOW, THEREFORE, the City Council of the City of San Leandro does RESOLVE as

follows:

That the City of San Leandro and its agents shall comply with the provisions of the MTC's RM 2 Policy Guidance (MTC Resolution No. 3636); and

That the City of San Leandro certifies that the project is consistent with the Regional Transportation Plan (RTP); and

That the year of funding for any design, right-of-way and/or construction phases has taken into consideration the time necessary to obtain environmental clearance and permitting approval for the project; and

That the RM 2 phase or segment is fully funded, and results in an operable and useable segment; and

That the City of San Leandro approves the updated Initial Project Report, attached to this resolution; and

That the City of San Leandro approves the cash flow plan, attached to this resolution; and

That the City of San Leandro reviewed the project needs and has adequate staffing resources to deliver and complete the project within the schedule set forth in the updated Initial Project Report, attached to this resolution; and

That the City of San Leandro is an eligible sponsor of projects in the RM 2 Regional Traffic Relief Plan, Capital Program, in accordance with California Streets and Highways Code 30914(c); and

That the City of San Leandro is authorized to submit an application for RM 2 funds for the Downtown San Leandro BART Pedestrian and Bicycle Access Project in accordance with California Streets and Highways Code 30914(c); and

That the City of San Leandro certifies that the projects and purposes for which RM 2 funds are requested is in compliance with the requirements of the California Environmental Quality Act (Public Resources Code Section 2l000 et seq.), and with the State Environmental Impact Report Guidelines (I4 California Code of Regulations Section I5000 et seq.) and if relevant the National Environmental Policy Act (NEPA), 42 USC Section 4-1 et. seq. and the applicable regulations thereunder; and

That there is no legal impediment to the City of San Leandro making allocation requests for RM 2 funds; and

That there is no pending or threatened litigation which might in any way adversely affect the proposed project, or the ability of the City of San Leandro to deliver the project; and

That the City of San Leandro indemnifies and holds harmless MTC, its Commissioners, representatives, agents, and employees from and against all claims, injury, suits, demands, liability, losses, damages, and expenses, whether direct or indirect (including any and all costs

and expenses in connection therewith), incurred by reason of any act or failure to act of the City of San Leandro, its officers, employees or agents, or subcontractors or any of them in connection with its performance of services under this allocation of RM 2 funds. In addition to any other remedy authorized by law, so much of the funding due under this allocation of RM 2 funds as shall reasonably be considered necessary by MTC may be retained until disposition has been made of any claim for damages; and

That the City of San Leandro shall, if any revenues or profits from any non-governmental use of property (or project) occur, that those revenues or profits be used exclusively for the public transportation services for which the project was initially approved, either for capital improvements or maintenance and operational costs, otherwise the MTC is entitled to a proportionate share equal to MTC's percentage participation in the project (s); and

That assets purchased with RM 2 funds including facilities and equipment shall be used for the public transportation uses intended, and should said facilities and equipment cease to be operated or maintained for their intended public transportation purposes for their useful lives, that the MTC shall be entitled to a present day value refund or credit (at MTC's option) based on MTC's share of the Fair Market Value of the said facilities and equipment at the time the public transportation uses ceased, which shall be paid back to MTC in the same proportion that RM 2 funds were originally used; and

That the City of San Leandro shall post on both ends of the construction site(s) at least two signs visible to the public stating that the Project is funded with RM 2 Toll Revenues; and

That the City of San Leandro authorizes the City Manager or his designee to execute and submit an allocation request for the Construction phase with MTC for Regional Measure 2 funds in the amount of \$360,000.00, for the project, purposes and amounts included in the project application attached to this resolution; and

That the City Manager or his designee is hereby delegated the authority to make non-substantive changes or minor amendments to the Initial Project Report as he deems appropriate.

BE IT FURTHER RESOLVED:

That a copy of this resolution shall be transmitted to MTC.

B. Project Purpose

This project improves pedestrian acces and increases bicycle parking at the San Leandro BART station. The project provides increased safety and comfort for pedestrians by installing bulbouts on West Juana Avenue, a street heavily used to travel to and from the BART station. The improvements will enhance the pedestrian experience and usability for those that have difficulty crossing busy city streets. New electronic bicycle lockers will be installed at the BART station to increase the amount of secure bicycle parking facilities.

C. Project Description (please provide details)

The project builds from the City of San Leandro's Transit Oriented Development Strategy to improve connections between the downtown San Leandro BART Station and the community. The project improves the southern east to west pedestrian connection running along West Juana Avenue for approximately 1,100 feet. Sidewalk bulbouts and enhanced crosswalk treatment will be added along West Juana at the intersection of Carpentier, Clarke, and Hays Street. Sidewalk on one side of West Juana Avenue between San Leandro Boulevard and Carpentier Street will be widened to provide for comfortable pedestrian travel. Pedestrian level lighting will be extended from the downtown along West Juana Avenue towards the BART station.
