### **Current Agency Policies**

Section 225(b) of the Charter of the City of San Leandro requires a successful candidate for elective office to receive at least 50% plus one of the votes cast for that office. In the event that no candidate receives 50% plus one of the votes cast for that office, the Charter requires the City Council to provide for a runoff vote to determine the person elected. The Charter provides that the runoff system may include an instant runoff voting system (i.e., RCV).

### **Previous Actions**

- On April 19, 2010, the City Council passed to print and adopted Ordinance No. 2010-005, providing for the conduct of the General Municipal Election using RCV. The ordinance remains in effect for this election.
- On July 5, 2016, the City Council adopted Resolution No. 2016-090, calling the November 8, 2016 General Municipal Election, requesting the Alameda County Board of Supervisors permit the consolidation of the City's General Municipal Election with the Statewide General Election, and requesting that the ROV conduct the election on the City's behalf.
- On July 20, 2016, the City Council adopted Resolution No. 2016-103, placing Measure NN on the ballot, relating to the approval of a tax on cannabis businesses.
- On July 20, 2016, the City Council adopted Resolution No. 2016-104, placing Measure OO on the ballot, to amend the city's business license tax.
- Also on July 20, 2016, the City Council adopted Resolution No. 2016-105 placing measure PP on the ballot to seek voter approval to increase the city's existing Transient Occupancy Tax

### **Summary of Public Outreach Efforts**

- A Candidate Information page was added to the City website, listing the candidates' contact information, ballot designations and ballot statements, and pre-election campaign financial statements. The page was updated as new information was received.
- On September 12, 2016, City staff conducted a Candidate Orientation for all City Council candidates, and members of the public were invited. The Orientation provided information on City services and projects.
- On October 7, 2016, a Notice of Nominees for Public Office and Measures to be Voted On was published in the Daily Review newspaper, pursuant to Elections Code Section 12110.
- A webpage for The Notice of Nominees for Public Office and Measures to be Voted On was added to the City's website. A link to translate the website was prominently placed in the upper corner of the page to allow easy translation of the Notice into the four required languages: Spanish, Chinese, Tagalog and Vietnamese.
- An Election Campaign Sign webpage was created, to provide candidates and members of the public with information on the rules governing temporary political campaign signs.

### **Fiscal Impacts**

The cost of the November 8, 2016 election of three City Councilmembers and three ballot measures is estimated to be \$170,500.

**Budget Authority**

\$190,000 in the FY 2016-17 General Fund Account 010-11-031-5890 was budgeted for the 2016 election.

### Recitals

WHEREAS, a General Municipal Election was held and conducted in the City of San Leandro on Tuesday, the 8th of November, 2016, in consolidation with the Statewide General Election, as required by the California Elections Code, the Charter of the City of San Leandro, and the City of San Leandro Municipal Code; and

WHEREAS, notice of said election was duly and regularly given as required by law, voting precincts were properly established and election officers were duly and regularly appointed and election supplies furnished, and in all respects said election was held and conducted, the votes cast were received and canvassed, and the return thereof made, determined and declared in the time, form and manner required by law regulating and controlling such elections; and

WHEREAS, the qualified electors cast ballots at said election for the following Officials:

**City Councilmember, District 2**

**City Councilmember, District 4**

**City Councilmember, District 6**

WHEREAS, the qualified electors cast ballots at said election upon the following three proposed Measures:

**Measure NN** - To maintain and enhance the City of San Leandro, with funding that cannot be taken by Sacramento, including: social services, public art, programs that celebrate diversity, multilingual programming and other general city services, shall the City of San

Leandro levy an ongoing tax of up to 10% of gross receipts of cannabis (marijuana) businesses in the city, providing \$500,000 annually, requiring independent citizen oversight, financial audits, and that all funds stay in the City of San Leandro?

**Measure OO** - To maintain and enhance the City of San Leandro, with funding that cannot be taken by Sacramento, including: enhancing City infrastructure and general City services, shall the City of San Leandro modify the ongoing business license tax to reduce taxes for small businesses, charge 10 percent of gross receipts for parking lots, and charge \$100 per 1,000 square feet of warehouse and distribution space, providing \$800,000 annually, requiring independent taxpayer oversight, and all funds stay in San Leandro?

**Measure PP** - To maintain and enhance the City of San Leandro, with funding that cannot be taken by Sacramento, including: enhancing library programming for children, more space for books, reference materials and public access computers, enhancing parks and infrastructure, and other general City services, shall the City of San Leandro increase the ongoing transient occupancy tax charged to hotel guests from 10% to 14%, providing \$200,000 annually, requiring independent citizen oversight, financial audits, and all funds staying in the City of San Leandro.

WHEREAS, a canvass of the returns of said election was made by the Registrar of Voters of Alameda County, a copy of which is attached; and

WHEREAS, the City Council of the City of San Leandro met in the regular meeting place of the Council on the 5th day of December, 2016, to declare the results of said election in compliance with Section 10263 of the California Elections Code; and

WHEREAS, the City Council finds as a result of said canvass that the number of votes cast, the names of the persons voted for, and other matters required by law are as hereinafter stated.

NOW, THEREFORE, the City Council of the City of San Leandro does RESOLVE and declare as follows:

A General Municipal Election was held and conducted in this City on Tuesday, November 8, 2016, at the time and in the form and manner required by law.

There were \_\_\_ consolidated precincts established for the purpose of holding said election.

The total number of ballots cast at said election, for the candidates for City Council Districts 2, 4 and 6; and upon Measures NN, OO and PP was \_\_\_\_\_.

BE IT FURTHER RESOLVED, that at said election, the following persons were elected to the following offices respectively:

Ed Hernandez, Councilmember, District 2, for a full term of four years from and after January 1, 2017, and until his successor is elected and qualified.

Benny Lee, Councilmember, District 4, for a full term of four years from and after January 1, 2017, and until his successor is elected and qualified.

Pete Ballew, Councilmember, District 6, for a full term of four years from and after January 1, 2017, and until his successor is elected and qualified.

BE IT FURTHER RESOLVED that Measure NN received a majority of the affirmative votes cast at said election for said Measure, and is hereby declared to have passed. The approval of Measure NN results in the adoption of an Ordinance of the People of the City of San Leandro, enacting a cannabis tax; and

BE IT FURTHER RESOLVED that Measure OO received a majority of the affirmative votes cast at said election for said Measure, and is hereby declared to have passed. The approval of Measure OO changes how the Business License tax is calculated and/or charged upon certain business activities within the City, resulting in reduction in the business license tax for some business activities and increase in the business license tax for other business activities; and

BE IT FURTHER RESOLVED that Measure PP received a majority of the affirmative votes cast at said election for said Measure, and is hereby declared to have passed. The approval of Measure PP results in an increase in the city's Transient Occupancy Tax.
