2. DISCUSSION ITEMS

2.A. Discussion Regarding MacArthur Blvd/Superior Ave Traffic Roundabout

Associate Engineer Kyle Lei presented an update on the MacArthur Blvd/Superior Ave Traffic Roundabout project.

Mayor Cutter expressed concerns regarding bicyclists and pedestrians in close proximity to each other on the sidewalk as well as the crosswalk east of the roundabout that crosses on-coming traffic from vehicles exiting the freeway. To prevent an accident, she prefers locating the crosswalk elsewhere, and providing better accommodation for bicyclists in the design.

Councilmember Lopez commented that at a 2016 community meeting, 30 out of 32 residents wanted speed bumps installed on Superior Ave. Committee expressed a desire for MacArthur/Superior roundabout to be built well and to accommodate all users to gain residents' support for future roundabouts.

Councilmember Lopez inquired about the possibility of using redevelopment funds to install traffic signals instead of a roundabout so that bicyclists will not have to share the sidewalk.

K. Cooke suggested staff research ROW requirements for an alternative design that better accommodates bicycles including the purchase of property from Caltrans.

J. Kay stated that staff would need to study the feasibility of using these funds to install traffic signals since redevelopment funds were returned to the City specifically for a roundabout project.

Member of the public S. Hufstader commented that the current design concept will benefit bicycles since the left turn off Foothill Blvd is already a difficult maneuver. Forcing bicyclists to dismount would be problematic. She observed that if the goal is to have bikes on the street, then a slip lane is a problem. If the goal is to have bikes on sidewalk away from traffic, then space is a problem. She suggests a separate bikeway on the same grade as the sidewalk using paving separators.

Mayor Cutter expressed her appreciation for the work staff has put into this current design.

Committee requests to staff:

- K. Lei to provide Mayor Cutter with a dimensioned drawing of the latest concept; she will email it to the Mayor of Carmel, Indiana. This locale has many roundabouts that the City's design can be compared to.
- Revise design for May 3rd meeting. Further presentation at public meetings to follow.
- Project consultant to attend future Committee meetings.

 - Overlay/Rehab 15-16 to be complete by end of April.
 - Street Sealing 16-17: 25 street segments in the Manor Blvd. area will start mid-summer.

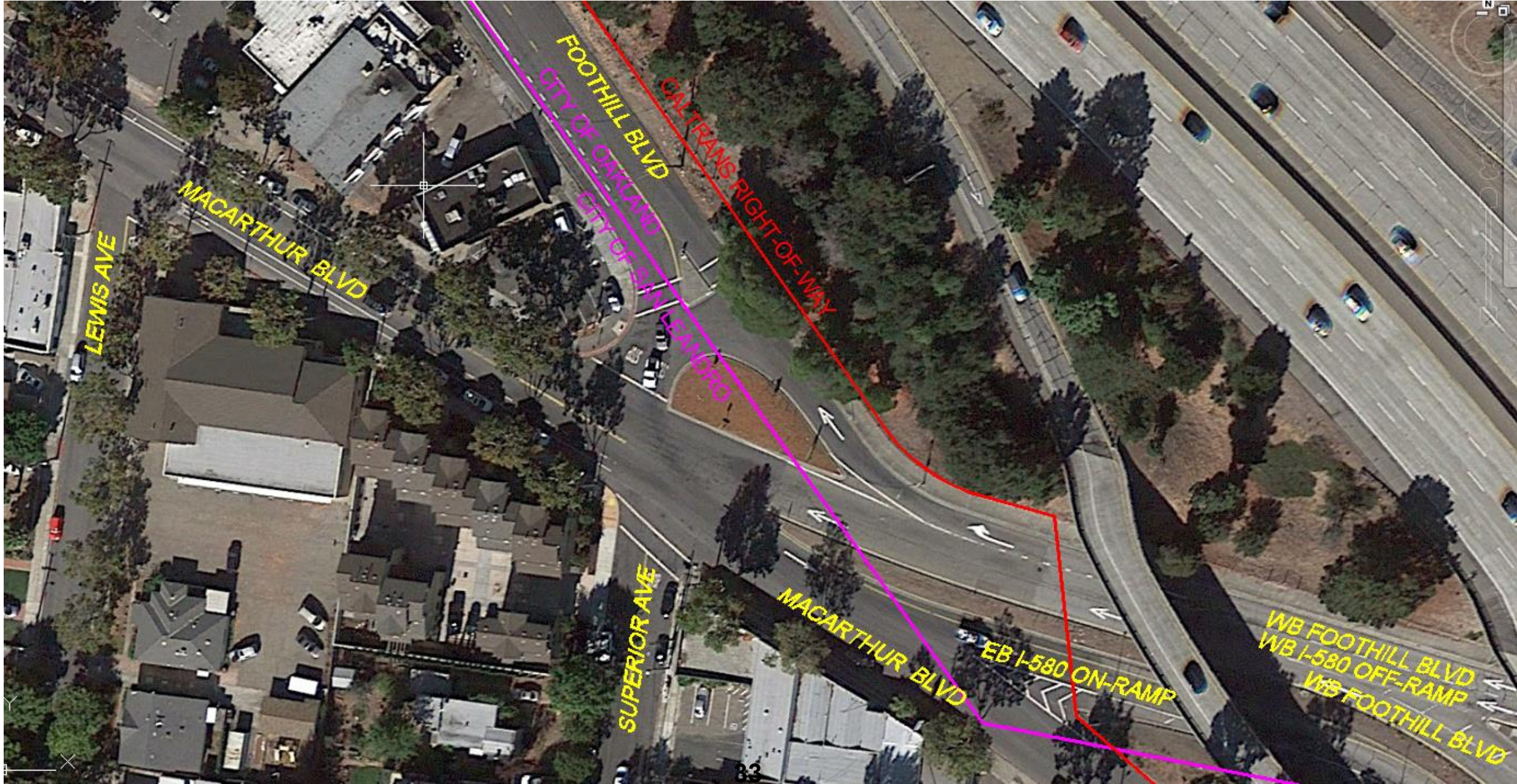

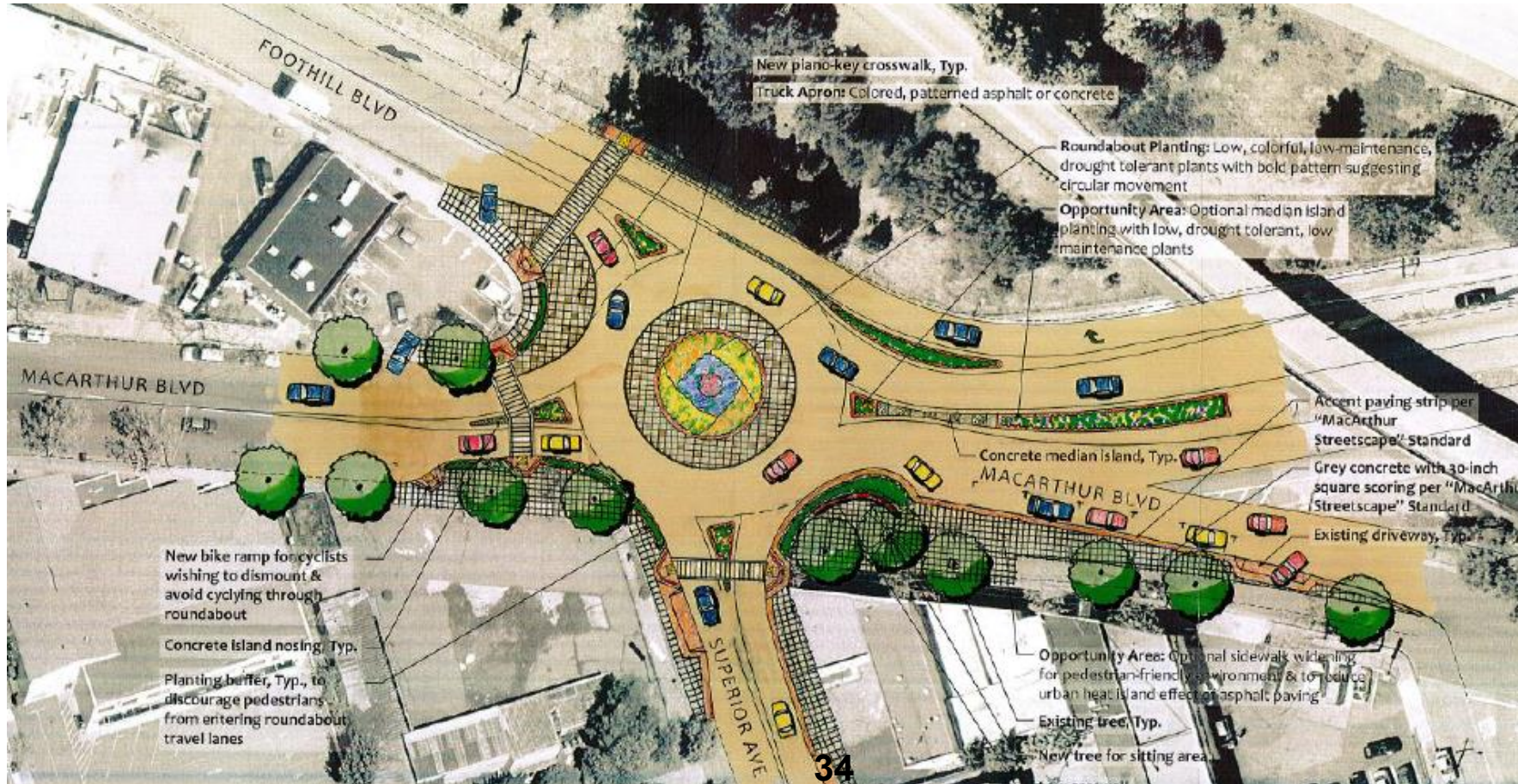


Project Background



Project Background

- Long wait times
- Speeding / reckless driving
- High accident rate
- A roundabout was recommended per traffic studies done in 2006 & 2015
- Previous concept shown below



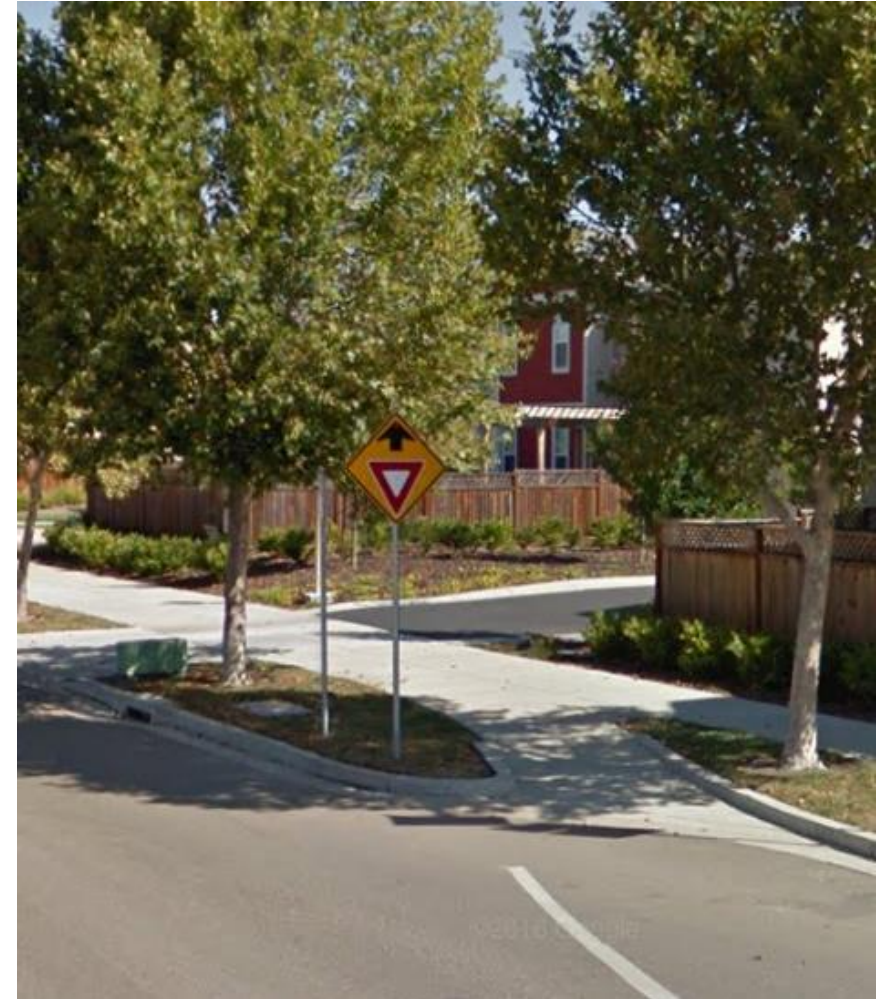
Conceptual Design

New features include:

- Fourth crosswalk east of roundabout with pedestrian refuge areas
- Additional bike ramps
- Accommodations for larger design vehicle movements

Additional Traffic Calming Measures on Superior Ave:

- Speed humps or speed feedback signs to be considered



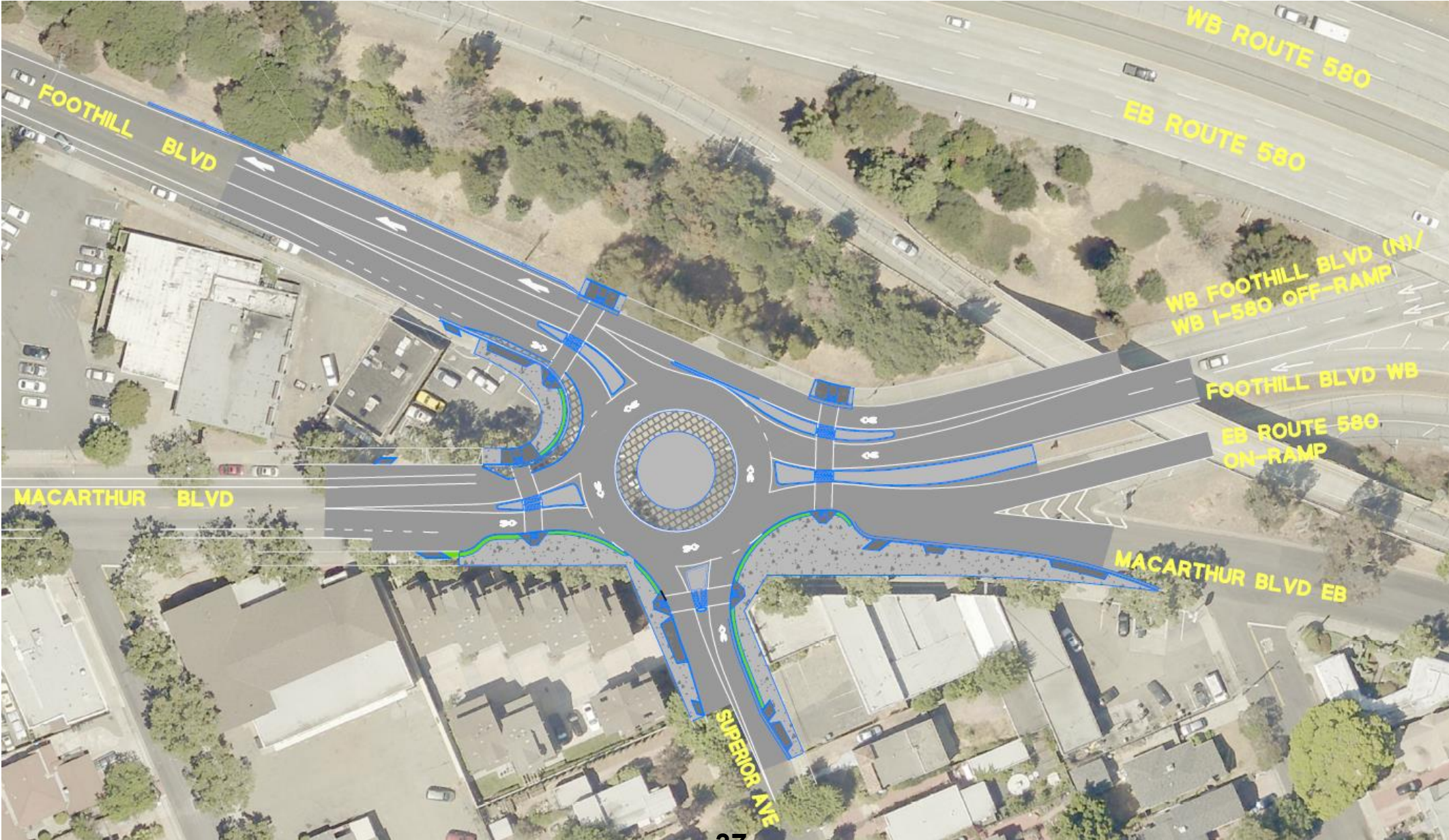
Conceptual Design

New features did not include:

- Separated bike lanes (lack of available right-of-way)
- Elimination of slip lane from westbound Foothill Blvd (would negatively impact functionality of roundabout)

Next steps

- Present revised roundabout design at a second public meeting (approximately one month from today)
- Also seek input on through an online “open town hall” using the Peak Democracy website



Next steps

- Send conceptual plan to Bike East Bay for their review and comments
- Mail questionnaire to residents on Mitchell Ave and Lewis Ave about their preference for traffic calming measures
