Asset Seizure Fund 146 Fund Balance in the Amount of \$180,000 for Police

Equipment and Projects in 2018-19

SUMMARY AND RECOMMENDATIONS

Staff recommends that the City Council approve a resolution to appropriate Federal and State Asset Seizure funds (Fund 146) fund balance in order to purchase necessary equipment and fund projects in Fiscal Year 2018-19.

BACKGROUND

The Police Department has both software and equipment it seeks to fund with money from the Fund 146 (Federal) Asset Seizure Fund Balance. The projects below all comply with the federal requirements related to the use of these special funds.

Federal Funding

- \$50,000 to fund an upgrade to the current Tyler/New World Enterprise records management system that will help facilitate the department's migration from the FBI's Uniform Crime Reporting (UCR) system toward the National Incident Based Reporting (NIBRS) system;
- 2. \$25,000 to purchase police equipment and supplies, including an unmanned aerial vehicle to augment current police resources during critical incidents.

\$75,000 (Federal) Asset Seizure Fund Balance appropriation requested

The Police Department has two separate projects it seeks to fund with money from the Fund 146 (State) Asset Seizure Fund Balance. The projects below all comply with the state requirements related to the use of these special funds.

State Funding

- 1. \$35,000 to digitize archived police records that must be retained and currently take up limited space within the police department;
- 2. \$70,000 to fund a building project to permanently address overnight housing of San Leandro's animal population and the department's MedEvac at the Public Works Service Center.

\$105,000 (State) Asset Seizure Fund Balance appropriation requested

Analysis

The requested appropriations will provide sworn police officers with the software solutions, equipment, supplies, and services necessary for advancing public safety within San Leandro. They are not currently budgeted in the General Fund operating budget for the Police Department in Fiscal Year 2018-19.

The Police Department is committed to advancing the City Council's Goal to provide high quality public safety by growing our partnership with the community. To that end, the Police Department sees a need to fund projects that enhance public safety during critical incidents, comply with federally mandated reporting requirements, and ensure the safety of San Leandro's animal population overnight or during an emergency.

Not funding these projects will jeopardize operational continuity for the Police Department and place a burden on the General Fund this budget cycle and the next.

Fiscal Impact and Budget Authority

There is no fiscal impact to the General Fund. The funds are restricted to specific needs. The Police Department is required to spend the money in a way that advances public safety. These projects all comply with that legal requirement.

The Police Department requests a total appropriation of \$75,000 from Fund 146 (Federal) Asset Seizure Fund Balance into the following accounts:

- 1. \$50,000 into account #146-21-014-5311
- 2. \$25,000 into account #146-21-014-6272

The Police Department requests a total appropriation of \$105,000 from Fund 146 (State) Asset Seizure Fund Balance into the following accounts:

- 1. \$35,000 into account #146-21-017-5120
- 2. \$70,000 into account #146-21-017-7210

WHEREAS, the Police Department has multiple projects it needs to fund with money from the Asset Seizure Fund; and

WHEREAS, the Asset Seizure Fund account is a special reserve account to fund police-specific needs, like equipment, supplies, or services that comply with the Department of Justice's Guidelines for use of such funds; and

WHEREAS, this appropriation of funds will supply police officers with the equipment, supplies, and services necessary to serve public safety that are not currently budgeted in the General Fund, as detailed in the associated staff report.

NOW, THEREFORE, the City Council of the City of San Leandro does **RESOLVE** as follows:

That the following Asset Seizure appropriations are approved, as more fully described in the staff report associated with this resolution:

- \$50,000 to fund an upgrade to the current Tyler/New World Enterprise records management system for NIBRS compliance-Federal Asset Seizure (Account #146-21-014 -5311);
- 2. \$25,000 to purchase police equipment and supplies-Federal Asset Seizure (Account #146-21-014-6272);
