TITLE:Staff Report for a Resolution of the City of San Leandro City Council to Authorize Submission of a Request to the Metropolitan Transportation Commission for the Allocation of Fiscal Year 2019-20 Transportation Development Act Article 3 Pedestrian/Bicycle Project Funding to Install Pedestrian Improvements		

#### RECOMMENDATIONS

Staff recommends that the City Council adopt a Resolution authorizing the City Manager to submit a request to the MTC for the allocation of Fiscal Year 2019-20 Transportation Development Act (TDA) Article 3 Pedestrian/Bicycle project funding to install pedestrian improvements.

## BACKGROUND

The Local Transportation Fund, which is a one-quarter percent sales tax in Alameda County initiated by the State Legislature in 1972, funds the TDA grant program. In the nine-county Bay Area region, the Metropolitan Transportation Commission (MTC) makes TDA Article 3 funds available for pedestrian/bicycle purposes. Each year, the MTC allocates TDA funds to eligible claimants after a review of applications from counties and congestion management agencies. Alameda County is responsible for submitting an annual program of projects that are implemented by each local agency in the county. The TDA funds are distributed by population.

## <u>Analysis</u>

The City annually applies for TDA funds from the MTC for pedestrian improvements. The City is entitled to \$90,860 for Fiscal Year 2019-20. The TDA funds will be used to install disabled access ramps and other pedestrian improvements at various locations throughout the City. The work will be completed as part of the City's Sidewalk Repair Project (2020.0060) which includes requested curb ramp installations not associated with street resurfacing work along with other sidewalk improvements.

## Current Agency Policies

• Maintain and enhance San Leandro's infrastructure.

### Previous Actions

• On May 21, 2018, by Resolution No. 2018-046, the City Council authorized the filing of a claim with the MTC for allocation of TDA Article 3 funds for FY 2018-19.

#### **Committee Review and Actions**

• On February 21, 2019, the Bicycle and Pedestrian Advisory Committee reviewed and approved the proposed project for the use of TDA funds as required by the MTC.

#### Applicable General Plan Policies

- Policy T-3.2: Funding. Maximize the City's eligibility for funding for bicycle and pedestrian improvements, and aggressively pursue such funding to complete desired projects.
- Policy T-3.6: Pedestrian Environment. Improve the walkability of all streets in San Leandro through the planning, implementing, and maintaining of pedestrian supportive infrastructure.
- Policy T-3.7: Removing Barriers to Active Transportation. Reduce barriers to walking and other forms of active transportation such as incomplete or uneven sidewalks, lack of wheelchair ramps and curb cuts, sidewalk obstructions including cars parked on sidewalks, trail gaps, wide intersections, and poor sidewalk connections to transit stops.

#### Environmental Review

The work to be performed is categorically exempt from the California Environmental Quality Act according to Public Resources Code §21084 and CEQA Guidelines Article 19, Section 15301 "Existing Facilities".

#### Fiscal Impacts

MTC allocated \$90,860 in TDA funding to the City in FY 2019-20, with no local match requirement. The funds will be appropriated when a construction contract is awarded, with reimbursement by MTC once the project is complete.

#### **Budget Authority**

The City's proposed biennial budget reflects an Outside Funding/Grant amount of \$90,860 for Project 2020.0060 "Sidewalk Repair" project. Expenditures will not exceed the TDA funding allocation.

TITLE:	RESOLUTION of the City of San Leandro City Council to Authorize Submission of a Request to the Metropolitan Transportation Commission (MTC) for the Allocation of Fiscal Year 2019-20 Transportation Development Act (TDA) Article 3 Pedestrian/Bicycle Project Funding to Install Pedestrian Improvements in the Amount of \$90,860		

WHEREAS, Article 3 of the Transportation Development Act (TDA), Public Utilities Code (PUC) Section 99200 et seq., authorizes the submission of claims to a regional transportation planning agency for the funding of projects exclusively for the benefit and/or use of pedestrians and bicyclists; and

WHEREAS, the Metropolitan Transportation Commission (MTC), as the regional transportation planning agency for the San Francisco Bay region, adopted MTC Resolution No. 4108, entitled "Transportation Development Act, Article 3, Pedestrian and Bicycle Projects," which delineates procedures and criteria for submission of requests for the allocation of "TDA Article 3" funding; and

WHEREAS, MTC Resolution No. 4108 requires that requests for the allocation of TDA Article 3 funding be submitted as part of a single, countywide coordinated claim from each county in the San Francisco Bay region; and

WHEREAS, the City of San Leandro desires to submit a request to MTC for the allocation of TDA Article 3 funds to support the projects described in Attachment B to this resolution, which are for the exclusive benefit and/or use of pedestrians and/or bicyclists; and

WHEREAS, the City Council is familiar with the contents thereof; and

WHEREAS, the City Manager recommends approval of said submission; and

WHEREAS, \$90,860 of TDA Article 3 grant funds must be appropriated for the Annual

Sidewalk Repair Project 2020.0060 (Fund 150-36-414) in the City's Fiscal Year 2019-20 Budget in order to fully fund the project.

NOW, THEREFORE, the City Council of the City of San Leandro does RESOLVE as follows:

1. That the City of San Leandro declares it is eligible to request an allocation of TDA Article 3 funds pursuant to Section 99234 of the Public Utilities Code; and

2. That there is no pending or threatened litigation that might adversely affect the project or projects described in Attachment B to this resolution, or that might impair the ability of the City of San Leandro to carry out the project; and

3. That the project has been reviewed by the Bicycle and Pedestrian Advisory Committee (BPAC) of the City of San Leandro; and

4. That the City of San Leandro attests to the accuracy of and approves the statements in Attachment A to this resolution; and

5. That a certified copy of this resolution and its attachments, and any accompanying supporting materials shall be forwarded to the countywide transportation planning agency and Alameda County for submission to MTC as part of the countywide coordinated TDA Article 3 claim; and

6. That \$90,860 of TDA Article 3 grant funds must be appropriated for the Annual Sidewalk Repair Project 2020.0060 (Fund 150-36-414) in the City's Fiscal Year 2019-20 Budget in order to fully fund the project.

- 1.
