Mayor Cutter indicated that Marina Boulevard is off the table and suggested Davis Street would be a better alternative route if considered.</li> <li>b. Vice Mayor Lopez indicated that bicycle access to Oyster Bay has been challenging through the Davis Street gate closure and would like to suggest expanding or improving the roadway infrastructure and review alternative solutions to lessen traffic congestion (multi-modal solution).
