COMMITTEE REQUESTS/DIRECTION TO STAFF:

- a. Councilmember Cox inquired about the possibility of increasing project estimates for CIP projects based on recent bid history and/or current labor and materials costs.
- b. Mayor Cutter would like more information from staff on change orders to contracts when the scope has not changed vs. change orders resulting from modifications to a project's scope. She requested differentiation between these two types when change orders are brought for the Council's review and approval.
