1.B. Announcements

City Manager Kay welcomed Susan Hsieh as the new Finance Director.

2. DISCUSSION ITEMS

2.A. 20-291 Capital Improvement Program (CIP) Budget Review

City Engineer Thom provided an overview of the Capital Improvement Program (CIP) budget. Mr. Thom shared a list of CIP projects and potential solutions to address the General Fund projected shortfall of approximately \$10.5 million.

The six potential solutions discussed are as follows:

- 1. Defer Marina Boat Harbor Decommissioning
- 2. Defer Trash Capture
- 3. Defer Competition Pool
- 4. Defer Improvements to Casa Peralta
- 5. Reduce Road Funding
- 6. Alvarado Park Development Fee Swap

The City Council will be asked to approve any proposed changes to the CIP budget.

3. PUBLIC COMMENTS

There was approximately one (1) public speaker.

Comments were provided by Douglas Spalding.

4. COMMITTEE MEMBER COMMENTS

Comments and questions were provided by Mayor Cutter, Councilmember Hernandez, and Councilmember Lee. Recommendations were made as follows:

Deferring the Competition Pool is not recommended, as the opportunity may not come up again in the future. It is also a potential resource for community use, mental health/human services, well-being.

Deferring the third and final phase of "Trash Capture" is not recommended if the compliance date is not delayed.

Deferring Casa Peralta seems preferable. More information is requested (move forward with "bare minimum" improvements, look at cost/benefit of improvements, look at opportunities for fundraising or grants).

Reducing road funding is not preferable, as road repair is a currently a high priority.

Consider "road or street diets", repurpose roads as part of development for community use: pedestrians and bicycles only - no cars.

Deferring Alvarado Park Development seems reasonable for now, as facilities are still being utilized by Alameda County and the City of Hayward.

For "Defer Marina Decommissioning":

- The appropriate verbiage should be used (e.g., demolition of obsolete infrastructure versus decommissioning)
- How will this affect existing revenue?
- Should the City consider the Marina as a viable revenue generator for the future?
