

Overall Sentiment







I strongly support requiring proof of vaccination for restaurants, bars, etc. It is clear that vaccination is what is bringing us out of the pandemic: in the past 7 days, California counties with vaccination rates less than 50% had 26 COVID cases per 100,000 population; those with rates of 50-70% had 14 cases; those with 70% or more, which also tend to have stricter masking orders, 8 cases. But cases are starting to rise again (+10% in the past

new weeks) and more needs to be done to put an end to it. This mandate will serve as a further incentive, among others needed like employer mandates, to people to get vaccinated, who are mostly apathetic rather than strongly resistant. It will also cut cases directly given the high transmissibility of the delta variant (not eliminated by vaccines, but significantly reduced) in places where the public gathers, and will save lives of people disproportionately with immunosuppressing conditions.

It should also not significantly hurt restaurant business: some refuseniks may stay away, but others will feel safer and come more frequently. I personally have gone more than before to San Francisco restaurants and events feeling the security of vaccine cards being checked at the door there.

Ideally Alameda County would have already implemented this, as Contra Costa has too; but since they unaccountably haven't, we need to take responsibility for our own community with this measure,
