The City Council of the City of San Leandro does RESOLVE as follows:

1. That following notice and hearing as required by law, Title 6, Chapter 4, Section 6.4.100 of the San Leandro Administrative Code ("Fee Schedule") is amended as provided in the attachment; and

2. That the adopted Fiscal Year 2021-2022 Fee Schedule, in the section entitled "RECREATION AND HUMAN SERVICES DEPARTMENT - Facility/Parks/Pools/Fields Rental Fees Section" is approved as amended, attached hereto and made a part hereof; and

3. That the fees in subsequent fiscal years shall be amended in an amount up to the amounts specified in the attached schedule; and

4. That the provisions of the amended Fee Schedule shall take effect immediately upon approval of this Resolution.
