TITLE: Staff Report for a City of San Leandro City Council Resolution to Approve

Amendment No. 1 to the Fiscal Year 2021-2022 Contract Between the City of San Leandro and Centro Legal de la Raza for an Amount Not to Exceed \$65,000 to Administer the City's Tenant/Landlord Counseling (increases FY2021-2022

Agreement by an additional \$20,000)

SUMMARY AND RECOMMENDATIONS

Staff recommends that the City Council approve the resolution for Amendment No. 1 to the FY 2021-2022 contract with Centro Legal de la Raza to operate the City's Tenant/Landlord Counseling Program. This action will amend Centro Legal's contract by increasing the original contract amount of \$45,000 by an additional \$20,000 for a total amount not to exceed \$65,000. On June 28, 2021 the City Council adopted the FY 2021-2023 Biennial Budget (Resolution No. 2021.096) that appropriated an additional \$20,000 to augment the existing allocation of General Fund monies for the City's Tenant/Landlord Counseling currently operated by Centro Legal de la Raza. Because the additional \$20,000 placed in the Centro Legal contract will take it over \$50,000, the City Council must review and approve the increase of the contract to an amount not to exceed \$65,000.

BACKGROUND & ANALYSIS

This agreement will augment the existing General Fund allocation of \$45,000 for Centro Legal de la Raza's administration of the City's Tenant/Landlord Counseling Program, which includes legal services for low-income renters. Centro Legal de la Raza is also currently under contract with the City of San Leandro and wrapping up final delivery of the highly successful Emergency Rental Assistance Payments (U.S. Department of Housing and Urban Development 2020 CARES Act, CDBG-CV funding). As the various tenant protections provided by the State, County and local eviction moratoriums begin to expire, both programs combined advance the Housing Division's efforts to promote housing stability and efforts to prevent homelessness for lower income renters due to impacts from COVID-19. The recommended action will expand and enhance the

Tenant/Landlord Counseling Program, which will enable the City to support substantially more San Leandro renter households as they continue to cope with the economic impacts of the COVID-19 pandemic and related closures due to the shelter in place orders.

No. 1 to the Fiscal Year 2021-2022 Consulting Services Agreement Between the City of San Leandro and Centro Legal de la Raza for an Amount Not to Exceed

\$65,000 to Administer the City's Tenant/Landlord Counseling Program

(increases FY2021-2022 Agreement by an additional \$20,000)

WHEREAS, a Consulting Services Agreement for the Tenant/Landlord Counseling Program between the City of San Leandro and Centro Legal de la Raza, a copy of which is attached, is presented to the City Council; and

WHEREAS, on June 28, 2021 the City Council adopted the FY 2021-2023 Biennial Budget (Resolution No. 2021-096) that identified an additional \$20,000 to augment the existing allocation of general funds for the Tenant/Landlord Counseling Program currently operated by Centro Legal de la Raza; and

WHEREAS, the City has an existing consulting services agreement with Centro Legal de la Raza using a general fund allocation of \$45,000 that has provided effective management of Tenant/Landlord Counseling and Legal Services since July 2020; and

WHEREAS, the various tenant protections provided by the State, County and local eviction moratoriums are expected to expire over the next year; this contract will advance the Housing Division's efforts to promote housing stability and prevent homelessness for lower income renters due to impacts from COVID-19; and

WHEREAS, Amendment No. 1 to the Consulting Services Agreement between the City of San Leandro and Centro Legal de la Raza for the Administration of the City's Tenant/Landlord Counseling Program is presented to the City Council; and

WHEREAS, the City Council is familiar with the contents thereof; and

WHEREAS, the City Manager recommends approval of Amendment No. 1 to said agreement.

NOW, THEREFORE, the City of San Leandro City Council hereby RESOLVES as follows:

That Amendment No. 1 to said agreement with Centro Legal de la Raza for an additional \$20,000 for a total not to exceed amount of \$65,000 is hereby approved and execution by the City Manager is hereby authorized.

AMENDMENT NUMBER ONE CONSULTING SERVICES AGREEMENT BETWEEN THE CITY OF SAN LEANDRO AND CENTRO LEGAL DE LA RAZA FOR

ADMINISTRATION OF THE CITY'S TENANT/LANDLORD COUNSELING PROGRAM

This Amendment Number One ("Amendment")	is made by and between the
City of San Leandro ("City") and Centro Legal de la Rai	za ("Consultant") (together
sometimes referred to as the "Parties") as of	, 2021, and amends that
certain Consulting Services Agreement ("Agreement")	dated July 1, 2021, between the
Parties.	• • •

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Subrecipient administers the Tenant/Landlord Counseling Program that also includes legal services to protect tenant rights and to preserve housing stability; and

WHEREAS, Consultant provides counseling services--regardless of income level--that are available to tenants who are residents of the City of San Leandro and owners/property managers of residential rental properties in the City of San Leandro and who seek advice and counseling on tenant and landlord rights and responsibilities; and

WHEREAS, Consultant provides legal services primarily targeting lower income tenant households whose rights are violated and/or are at risk of housing instability; and

WHEREAS, on June 28, 2021, the San Leandro City Council adopted Resolution No. 2021-, approving the Fiscal Years 2021-22 and 2022-23 City of San Leandro Biennial Budget that allows for an increase in funds to be provided to the Consultant by \$20,000 to a total amount of \$65,000 to expand the Tenant/Landlord Counseling Program for San Leandro.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

- 1. Section 2, "Compensation", of the Agreement is amended to increase the maximum amount of funds to be provided to Consultant by \$20,000 to a total amount of \$65,000.
- 2. Exhibit A, "Scope of Work," Section 1. Basic Terms, "Concise Description of Program" is amended to increase the program delivery cost not to exceed \$65,000.
- 3. Exhibit B, "Budget" of the Agreement is hereby amended and replaced with the revised Budget, attached to this Amendment as Exhibit B and incorporated herein.
 - 4. All other terms shall remain in full force and effect.

5. This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement. The persons whose signatures appear below certify that they are authorized to sign on behalf of the respective Party.

i. Salaries, Wages, Fringe Benefits:

Staff Attorney at \$68,508. base salary, 38% FTE for this program, for a of total: 26,033.

 Primary responsibilities will include: directly representing low-income tenants in unlawful detainer trials and appeals; directly representing low-income tenants in administrative hearings; supervising and/or providing consultations at drop-in clinics; providing Know Your Rights presentations to community-based organizations; and representing Centro Legal de la Raza and its clients at community events, stakeholder meetings, City Council hearings, etc.

Directing Attorney, at \$100,000. base salary, 2% FTE for this program, for a total: \$2,000.

• Provide broad-level oversight of both the Legal Services and Rental Assistance Programs.

Junior Accountant, at \$61,350. base salary, 6% FTE for this program, for a total: \$3,681.

• Track and monitor expenses and prepare City billings and invoices as required.

Fringe Benefits, at 25% of base salaries, for a total of \$7,929.
