WITNESSETH: That the said parties of the first part, for and in consideration of the sum of One Dollar, the receipt whereof is hereby acknowledged, does grant, bargain, sell, and convey unto the said party of the second part, its successors and assigns, for highway purposes, all that land situated in the City of San Leandro, Alameda County, California, and particularly described as follows, to wit:

BEGINNING at a point on the northwestern line of West Avenue 132, formerly First Street, distant thereon south 62° west 803.84 feet from the southwestern line of Orchard Avenue; and running thence along said line of West Avenue 132 south 62° west 40 feet; thence north $27^{\circ} 45'$ west 560.85 feet; thence north 62° east 40 feet to a line drawn north $27^{\circ} 45'$ west from the point of beginning; and thence south $27^{\circ} 45'$ east 560.85 feet to the point of beginning.

Gentlemen:

Earlier this year the properties of M. A. Webb and D. A. Wells located on First Avenue were annexed to the City, however there is a lot 82x137.05 on First Avenue that was not annexed. Mr. Webb has just deeded a strip forty feet wide to the City up to First Avenue; Mr. Wells has deeded a strip twenty feet wide up to the rear of this lot. This sixty feet is to be an extension of Wayne Avenue. However it will be necessary to acquire a twenty foot strip through this lot, which is not in the City, to provide a uniform street width. We shall appreciate your cooperation in establishing a plan line or setback, so that no structure will be built on this twenty feet. Enclosed is a drawing which will help to make the above clear.
