EASEMENT

RICHFIELD OIL CORPORATION, a Delaware corporation, hereby grants to the CITY OF SAN LEANDRO, a municipal corporation, an easement for street, sewer, drainage and utility purposes, in, over, through and across the real property in the City of San Leandro, County of Alameda, State of California, described as follows:

BEGINNING at the point of intersection of the north-eastern line of Doolittle Drive, 80 feet wide, with the northwestern line of Williams Street, 60 feet wide, as said drive and street existed February 1, 1961; thence along the aforementioned northeastern line of Doolittle Drive north 26° 31' west 12.21 feet to a point of cusp with a tangent curve concave to the north, having a radius of 12 feet and a central angle of 90° 59'; thence along said curve southeasterly, easterly, and northeasterly 19.06 feet to a point of cusp with a tangent line, said tangent line being the aforementioned northwestern line of Williams Street; thence along the said northwestern line of Williams Street south 62° 30' west 12.21 feet to the point of beginning.

The above described parcel of land contains 114.36 square feet, more or less.

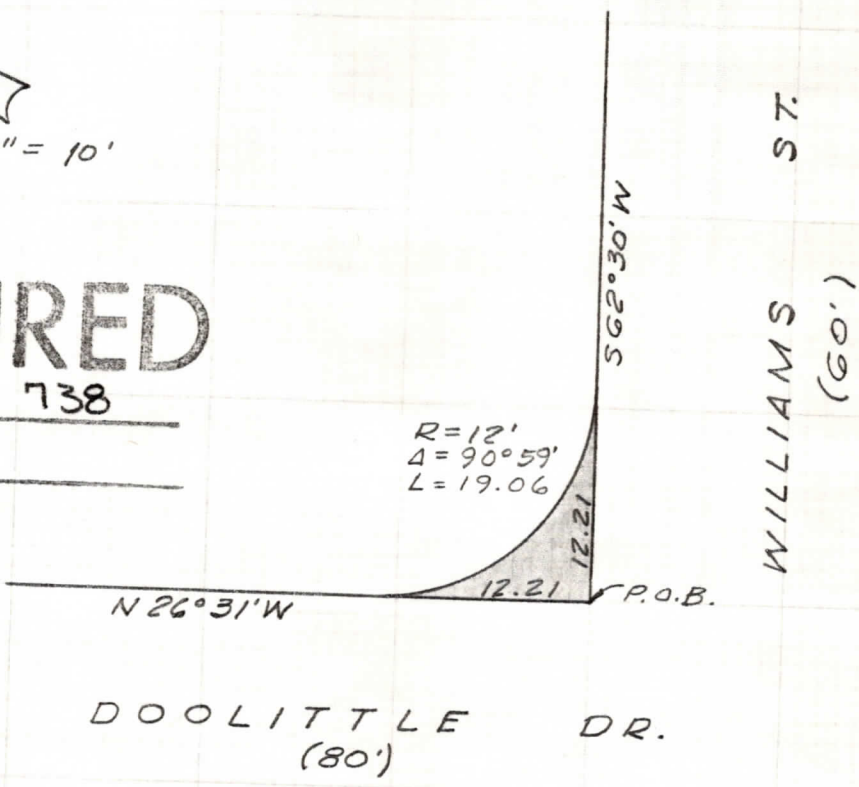

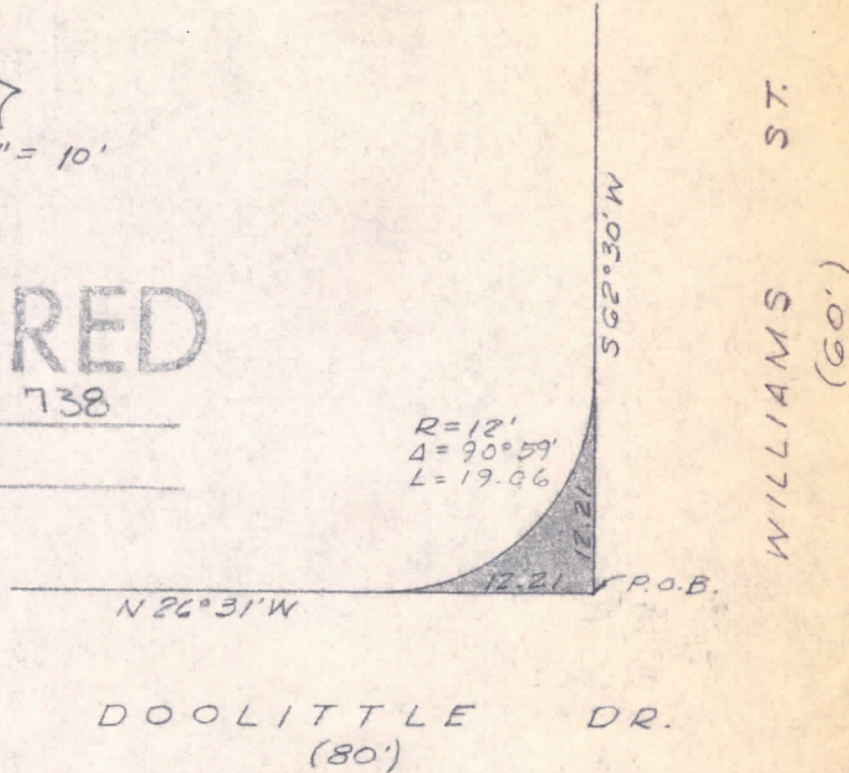
