12.00 feet to the TRUE POINT OF BEGINNING.

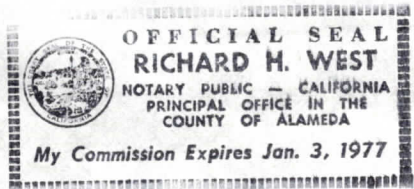

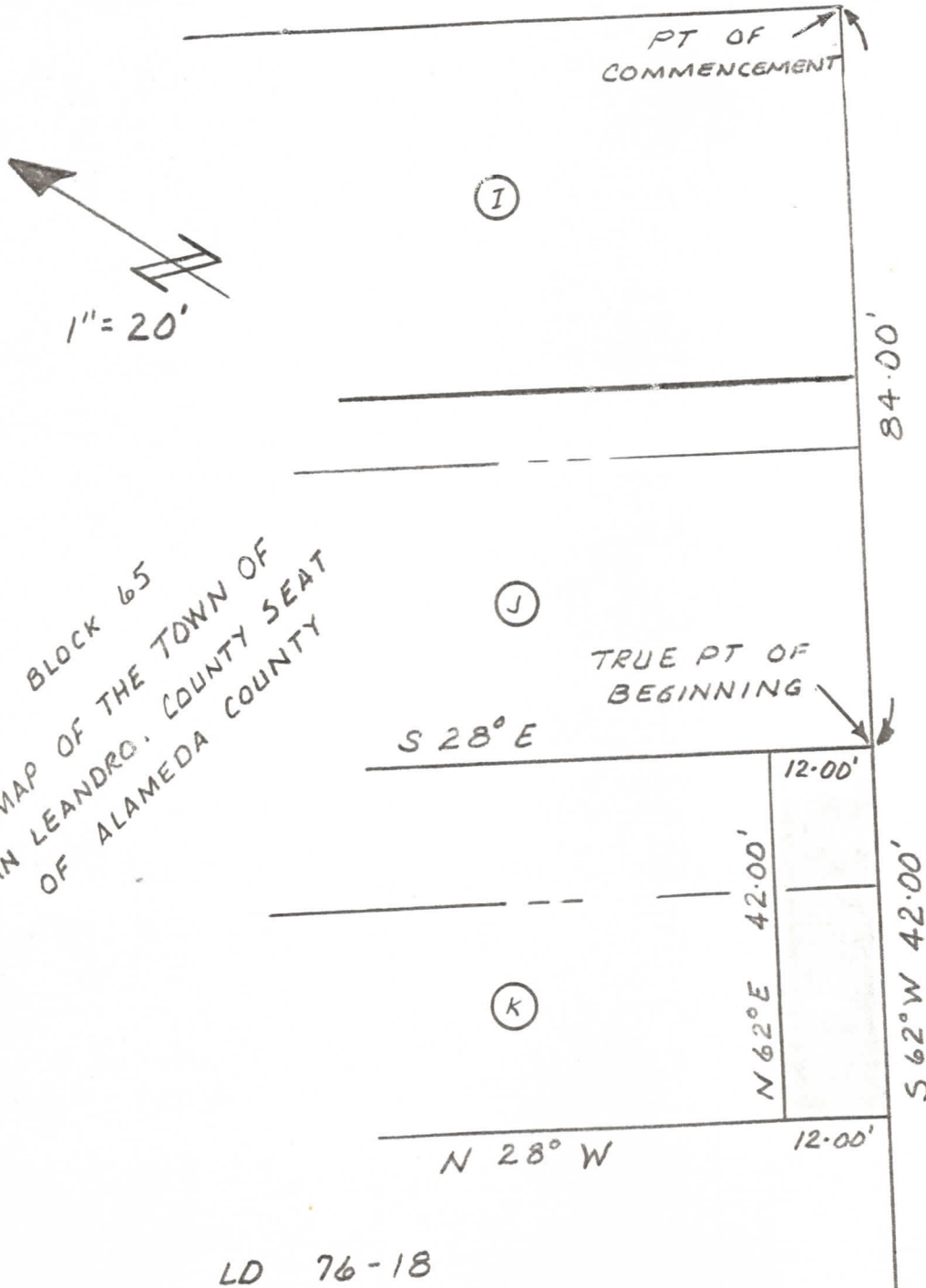

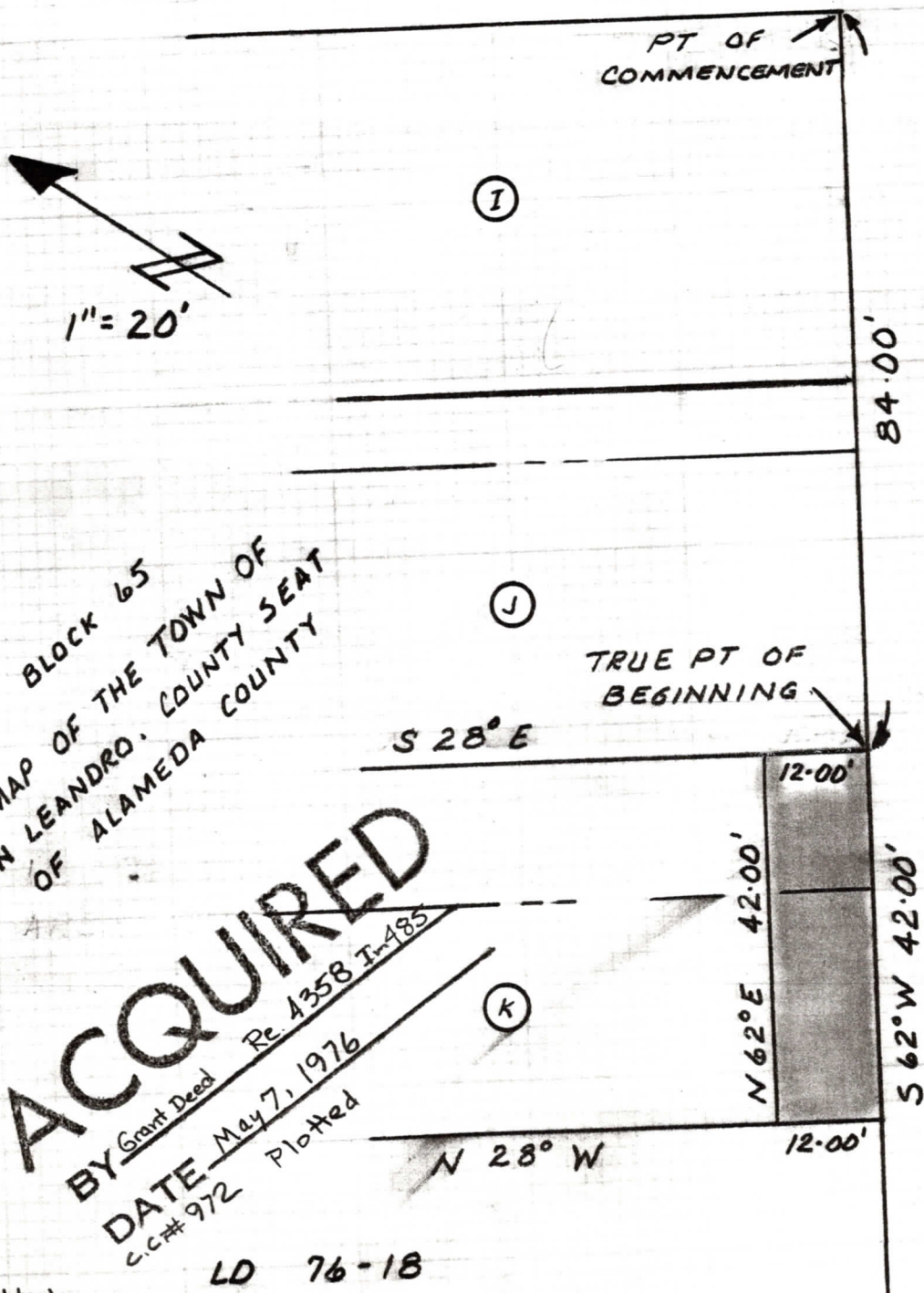
