



BEGINNING at the intersection of the southeast line of said 7 acre tract of land with the northeast line of Washington Avenue (60.00 feet wide), formerly Watkins Street; thence along the last said line north 27° 54' 00" west 176.73 feet; thence north 62° 06' 00" east 3.00 feet to a point on a non-tangent curve concave to the northeast, having a radius of 800.00 feet (a radial line to said curve at said point bears south 62° 06' 00" west); thence southeasterly along said curve through a central angle of 11° 39' 24" a distance of 162.76 feet to a reverse curve concave to the southwest, having a radius of 800.00 feet; thence southeasterly along said reverse curve through a central angle of 11° 39' 24" a distance of 162.76 feet to a tangent line drawn parallel with and 36.00 feet northeasterly, measured at right angles, from the said northeast line of Washington Avenue; thence along said tangent line south 27° 54' 00" east 37.75 feet to a tangent curve concave to the northeast, having a radius of 40.00 feet; thence southeasterly along said tangent curve through a central angle of 42° 24' 14" a distance of 29.60 feet to a point on a non-tangent line, said non-tangent line being also the southeast line of said parcel of land described in said deed from Judith Carrie Warren to Manuel Dutra Faria (a radial line to last said curve at last said point bears south 19° 41' 46" west); thence along said non-tangent line south 42° 00' 00" west 49.48 feet to the said northeast line of Washington Avenue; thence along the last said line north  $27^{\circ}$  54' 00" west 228.26 feet to the BEGINNING.

DEED

THE SINGER COMPANY, a corporation, hereby grants to the CITY OF SAN LEANDRO, a municipal corporation, all that real property situated in the City of San Leandro, County of Alameda, State of California, described as follows:

PARCEL I

A portion of that certain 2.47 acre tract of land described in the deed by Katie A. Mathews to L. PH. Bolander, Jr., dated August 14, 1929, recorded August 20, 1929, in Book 2202, page 138, Official Records of Alameda County, described as follows:

Commencing at the intersection of the northwestern boundary line of that certain parcel of land described in the deed by Katie A. Mathews, a single woman, to Pratt-Rymer Company, a corporation, dated March 6, 1928, recorded March 7, 1928, in Book 1837, page 122, Official Records of Alameda County, with the southwestern line of Washington Avenue, formerly Watkins Street; thence along said southwestern line of Washington Avenue, north 26° 38' 48" west (north 26° 38' 48" west being assumed the bearing of Washington Avenue for the purpose of this description) 63.26 feet to the ACTUAL POINT OF BEGINNING: thence south 63° 21' 12" west 5.00 feet; thence north 68° 12' 14" west 80.13 feet; thence south 89° 53' 17" west 107.20 feet to a tangent curve concave to the northeast, having a radius of 702 feet, and a central angle of 20° 08' 41"; thence along said curve southwesterly, westerly, and northwesterly 246.82 feet to its intersection with a non-tangent line, said non-tangent line being the southeastern line of Parcel One, as said parcel is described in the deed by Inter-Coastal Paint Corporation, a corporation organized under the laws of the State of Illinois, to the City of San Leandro, a municipal corporation, recorded July 12, 1963, in Reel 935, Image 31, Official Records of Alameda County, a radial line to said point bears south 20° 01' 58" west; thence along said non-tangent line, north 63° 21' 12" east 156.04 feet to a non-tangent curve concave to the northeast having a radius of 598 feet, and a central angle of 9° 50' 21" (a radial line to said point bears south 9° 43' 38" west); thence along said curve, southeasterly, easterly, and northeasterly 102.69 feet to a tangent line; thence along said tangent line, north 89° 53' 17" east 55.58 feet to a tangent curve concave to the northwest, having a radius of 40 feet and a central angle of 29° 18' 41"; thence along said curve, northeasterly 20.46 feet to a non-tangent line, a radial line to said point bears south 29° 25' 24" east; thence along said non-tangent line, north 31° 37' 14" east 38.73 feet to a non-tangent curve concave to the southwest, having a radius of 40 feet, and a central angle of 29° 18' 41", a radial line to said point bears south 87° 20' 07" east; thence along said curve, northerly 20.46 feet to a point of cusp with a tangent line, said tangent line being the aforementioned southwestern line of Washington Avenue south 26° 38' 48" east 211.84 feet to the actual point of beginning.
