AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN THE CITY OF SAN LEANDRO AND JASON R. ZALINSKI FOR POLICE BUILDING AND SOUTH OFFICES MODIFICATIONS PROJECT

This **Amendment No. 1** ("Amendment") is made by and between the City of San Leandro ("City") and <u>Jason R. Zalinski</u> ("Consultant") (together sometimes referred to as the "Parties") as of <u>December 2, 2022</u> | 2:58:53 PM PST _____, 2022, and amends that certain Consulting Services Agreement ("Agreement") dated June 16, 2021, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to serving as the Inspector of Record for the subject project, and

WHEREAS, the Parties desire to amend the Agreement to extend the term and increase the total compensation amount.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

- 1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from June 30, 2022, to June 20, 2023; and
- 2. Section 2 of the Agreement entitled "Compensation" is hereby amended to pay Consultant a sum not to exceed \$129,300; and
- 3. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended to read:

Compensation for the work noted in Exhibit A shall not exceed \$129,300. Work shall be reimbursed at a rate of \$110.00 per hour, unless the hours are on weekends or between 6:00 pm and 6:00 am, in which case the rate is \$165.00 per hour. There is a 3 hour minimum for each site inspection or visit.

4. All other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
