AMENDMENT NO. 1 TO NON-PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF SAN LEANDRO AND BAY AREA TREE SPECIALISTS FOR HIGH MAINTENANCE TREE TRIMMING

This **Amendment No. 1** ("Amendment") is made by and between the City of San Leandro ("City") and Bay Area Tree Specialists ("Contractor") (together sometimes referred to as the "Parties") as of October 16, 2022, and amends that certain Non-Professional Services Agreement ("Agreement") dated July 15, 2022, between the Parties.

WHEREAS, City and Contractor have executed the Agreement, pursuant to which Contractor has provided certain services to City with regard to high maintenance tree trimming; and

WHEREAS, the Parties desire to amend the Agreement to include additional high maintenance trees for trimming.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

- 1. Section 2 of the Agreement entitled "Compensation" is hereby amended to pay Contractor a sum not to exceed \$125,271; and
- 2. Exhibit A of the Agreement entitled "Scope of Services" is hereby amended to include High Maintenance Trees Phase 2; and
- 3. Exhibit B of the Agreement entitled "Compensation Schedule" is hereby amended to read: Phase II \$449/price per trim, \$126,169 Total for 160 trees.
 - 4. All other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
