

**AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN  
THE CITY OF SAN LEANDRO AND  
GOVINVEST  
FOR  
LABOR COSTING AND PENSION SOFTWARE AND SERVICES**

This **Amendment No. 1** (“Amendment”) is made by and between the City of San Leandro (“City”) and GovInvest, Inc. (“Consultant”) (together sometimes referred to as the “Parties”) as of December 31, 2022, and amends that certain Consulting Services Agreement (“Agreement”) dated September 6, 2022, between the Parties.

**WHEREAS**, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regards to Labor Costing Software and Services, and

**WHEREAS**, the Parties desire to amend the Agreement to add Pension Solutions and Services.

**NOW THEREFORE**, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. The first sentence of Section 2 of the Agreement, entitled “Compensation”, is hereby amended to read:

City hereby agrees to pay Consultant a sum not to exceed Thirty Thousand Dollars (\$30,000.00), notwithstanding any contrary indications that may be contained in Consultant’s proposal, for services to be performed and reimbursable costs incurred under this Agreement.

2. Exhibit A of the Agreement, entitled “Scope of Services”, is hereby amended to add the implementation of Pension Software and Services as provided by Exhibit A, attached hereto.

3. Exhibit B of the Agreement, entitled “Compensation Schedule & Reimbursable Expenses”, is hereby amended to include the cost of the Pension Module Software and services as provided by Exhibit B, attached hereto.

4. All other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
