

**AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN
THE CITY OF SAN LEANDRO AND
FEHR & PEERS
FOR
Crosstown Class IV Corridors Study**

This **Amendment No. 1** (“Amendment”) is made by and between the City of San Leandro (“City”) and Fehr & Peers (“Consultant”) (together sometimes referred to as the “Parties”) as of March 6, 2023, and amends that certain Consulting Services Agreement (“Agreement”) dated September 9, 2021, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to the Crosstown Class IV Corridors Study, and

WHEREAS, the Parties desire amend the Agreement to increase the total amount of compensation for costs incurred for City Council presentation preparation, Final report, and packaged deliverables.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 1.1 of the Agreement entitled “Term of Services” is hereby amended to extend the term from November 30, 2022 to April 30, 2023;
2. Section 2 of the Agreement entitled “Compensation” is hereby amended to pay Consultant a sum not to exceed \$353,601 (an increase of \$4,353);
3. Exhibit B of the Agreement entitled “Compensation Schedule & Reimbursement Expenses” of task phase 3.7 budget is hereby amended to read:

Original Contract Total	\$349,248
Amended Contract Total	\$353,601

4. All other terms shall remain in full force and effect.


This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.






