
NOTICE OF COMPLETION

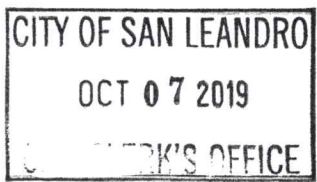



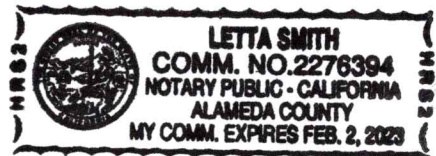
